This policy was developed with parents of students with SEN and members of the Governing Body. The policy will be reviewed annually.

Definition of SEN

A child or young person has SEN if they have a learning difficulty or disability which calls for special educational provision to be made for him or her.

A child of compulsory school age or a young person has a learning difficulty if he orshe:

- 1. Has a significantly greater difficulty in learning than the majority of others of the same age; or
- 2. Has a disability which prevents or hinders him or her from making use of facilities of a kind generally provided for others of the same age in mainstreamschools or mainstream post-16 institutions. SEN Code of Practice (2014, p 4)

Definition of disability

Many children and young people who have SEN may also have a disability under the Equality Act 2010 – that is '...a physical or mental impairment which has a long-term and substantial adverse effect on their ability to carry out normal day-to-day activities'. This definition provides a relatively low threshold and includes more children than many realise: 'long-term' is defined as 'a year or more' and 'substantial' is defined as 'more than minor or trivial' SEN Code of Practice (2014, p5)

<u>1</u> The kinds of special educational need for which provision is made at the school

At Aylesford School, we can make provision for every kind of frequently occurring special educational need without an Education, Health and Care Plan, for instance Dyslexia, Dyspraxia, Speech and Language needs, Autism, Asperger's Syndrome, learning difficulties and Social and Emotional and Mental Health difficulties. We make provision through our quality first teaching, training events for all staff and student profiling for students with SEN Support. We also visit all primary schools as part of our transition process to ensure we receive up to date information. In additionto the SENCO we have a team of teaching assistants and an Assistant SENCO who are available from 8.00am-4.00pm.

In the past and currently, we have supported students with a range of needs including cognition and learning (Dyslexia/Dyspraxia), Asperger's Syndrome, Autism, physical disabilities and social, emotional and mental health difficulties. There are other kinds of special educational need which do not occur as frequently and with which the school is less familiar, but we can access training and advice so that thesekinds of needs can be met.

The school also currently meets the needs of pupils with an Education, Health and Care plan with the following kinds of special educational need: Physical Disabilities including Cerebral Palsy, Visual Impairment Epilepsy, Autism (including Selective Mutism), Speech and Language Difficulties, Cognition and Learning and Social, Emotional and Mental Health difficulties. Decisions on the admission of pupils with an Education, Health and Care plan are made by the Local Authority.

The admission arrangements for pupils without an Education, Health and Care Plando not discriminate against or disadvantage disabled children or those with special educational needs.

2 Information about the policy for identification and assessment of pupils with SEN

At Aylesford School, we monitor the progress of all pupils at least 3 times a year to review their academic progress in our data collection points. We also use a range of assessments with identified pupils at various points:

- Baseline testing
- Star Reading Tests linked to accelerated reader
- Character Strengths and Behaviour for Learning

Where progress is not sufficient, even if special educational need has not been identified, we put in place extra support to enable the pupil to catch up. Examples of extra support include:

- Literacy and Maths Catch Up Interventions
- Access to Student Support Managers
- Flexible timetabling
- Subject specific interventions
- Touch typing
- Phonics support
- Homework club
- Extra transition programmes
- Express club to support those who find social time challenging
- Quiet club to support those who find social time challenging
- Working memory intervention
- Sensory Circuits
- Circle time
- Support from therapy dog Buddy
- A service level Educational Psychology service
- Specific group interventions for those with Autism Spectrum Condition (ASC)
- Intervention with school psychotherapist
- Intervention with school ELSA

Some pupils may continue to make inadequate progress, despite high-quality teaching targeted at their areas of weakness. For these pupils, and in consultation with parents, we will use a range assessment tools to determine the cause of the learning difficulty. At Aylesford School we are experienced in using the following assessment tools:

• Star Reading Tests linked to accelerated reader

- Suffolk Reading Tests
- LUCID Extract
- LASS Testing
- Boxall Profile
- GL Assessment PASS Tests tool to support pupil wellbeing
- Speech and language link

We have access to external advisers and specialist access arrangement assessors who are able to use the following assessment t

The purpose of this more detailed assessment is to understand what additional resources and different approaches are required to enable the pupil to make better progress. These will be shared with parents, put into a SEN Provision Plan and reviewed regularly, and refined or revised if necessary. At this point we will have identified that the pupil has a special educational need because the school is makingspecial educational provision for the pupil which is additional and different to what is normally available.

If the pupil is able to make good progress using this additional and different resource(but would not be able to maintain this good progress without it) we will continue to identify the pupil as having a special educational need. If the pupil is able to maintain good progress without the additional and different resources he or she will not be identified with special educational needs. When any change in identification of SEN is changed parents will be notified.

We will ensure that all teachers and support staff who work with the pupil are aware of the support to be provided and the teaching approaches to be used, this is sharedthrough a Student Profile and/or a Provision Plan.

The school will make and support parents with referrals sent from NHS Community Pediatric and are experienced with accessing NEFLT to support and make referrals. This will always be done in consultation with parents.

<u>3 Information about the school's policies for making provision for pupils with special educational needs whether or not they have EHC Plans, including</u>

<u>3a How the school evaluates the effectiveness of its provision for such pupils</u>

Each review of the SEN support plan will be informed by the views of the pupil, parents and class/subject teachers and the assessment information from teacherswhich will show whether adequate progress is being made.

The SEN Code of Practice (2014, 6.17) describes inadequate progress thus:

- Is significantly slower than that of their peers starting from the samebaseline
- Fails to match or better the child's previous rate of progress

- Fails to close the attainment gap between rate of progress
- Widens the attainment gap

For pupils with or without an Education, Health and Care Plan there will be an annualreview of the provision made for the child, which will enable an evaluation of the effectiveness of the special provision. The collation of all annual review evaluations of effectiveness will be reported to the governing body.

<u>3b The school's arrangements for assessing and reviewing the progress of pupilswith special</u> educational needs

Every pupil in the school has their progress tracked at least 3 times per year. In addition to this, pupils with special educational needs may have more frequent assessments of reading age, spelling age, etc. The assessments we use at Aylesford School are referred to in section 2. Using these it will be possible to see ifpupils are increasing their level of skills in key areas.

If these assessments do not show adequate progress is being made the SENsupport plan will be reviewed and adjusted.

<u>3c The school's approach to teaching pupils with special educational needs</u>

High quality teaching, differentiated for individual pupils, is the first step in responding to pupils who have or may have SEN. Additional intervention and support cannot compensate for a lack of good quality teaching. We regularly andcarefully review the quality of teaching for all pupils, including those at risk of underachievement. This includes reviewing and, where necessary, improving

teachers' understanding of strategies to identify and support vulnerable pupils andtheir knowledge of the SEN most frequently encountered SEN Code of Practice (2014, 6.37)

We follow the Mainstream Core Standards advice as developed by Kent CountyCouncil to ensure that our teaching conforms to best practice. Website link:

In meeting the Mainstream Core Standards the school employs some additional teaching approaches, as advised by internal and external assessments e.g. one toone tutoring / precision teaching / mentoring, small group teaching, use of ICT software learning packages. These are delivered by additional staff employed

through the funding provided to the school as 'notional SEN funding'

<u>3d How the school adapts the curriculum and learning environment for pupils withspecial</u> educational needs

At Aylesford School we follow the advice in the Mainstream Core Standards on howto adapt the curriculum and the learning environment for pupils with special educational needs. We also incorporate the advice provided as a result of assessments, both internal and external, and the strategies described in Education, Health and Care Plans.

As part of our requirement to keep the appropriateness of our curriculum andlearning environment under review, the Governors have made the following improvements as part of the school's accessibility planning:

3e Additional support for learning that is available to pupils with special educational needs

As part of our budget we receive 'notional SEN funding'. This funding is used to ensure that the quality of teaching is good in the school and that there are sufficient resources to deploy additional and different teaching for pupils requiring SEN support. The amount of support required for each pupil to make good progress will be different in each case and a full list of the interventions we can offer is on our provision map. In very few cases a very high level of resource is required. The funding arrangements require schools to provide up to £6000 per year of resources for pupils with high needs, and above that amount the Local Authority should provide up to the school. If a student requires above £6000 of additional support, then anapplication for High Needs Funding (HNF) is made to Kent County Council.

3f How the school enables pupils with special educational needs to engage in activities of the school (including physical activities) together with children who donot have special educational needs

All clubs, trips and activities offered to pupils at Aylesford School are available to pupils with special educational needs either with or without an Education, Health and Care Plan. Where it is necessary, the school will use the resources available to it to provide additional adult support to enable the safe participation of the pupil in the activity. Risk Assessments are undertaken prior to all trips to ensure the safety of allthose attending. In addition, we also enter into events and competitions designed especially for students with special educational needs and physical disabilities.

<u>3g Support that is available for improving the emotional and social development of pupils with special</u> educational needs

At Aylesford School we understand that an important feature of the school is to enable all pupils to develop emotional resilience and social skills, both through directteaching for instance PSHE through our mentor time programme, community interventions and indirectly with every conversation staff have with pupils throughout day.

For some pupils with the most need for help in this area we also can provide thefollowing:

Personalised mentoring with a member of the AEN team, external referral to CAHMs, time-out space for pupils to use when upset or agitated, Student Support Managers, referrals to Early Help Notifications, Circle Time, SocialUse of Language Programme, check-in mentoring with a TA, Drawing and Talking Therapy, access to school Psychotherapist, Lego therapy, access to school therapy dog and referral to Slideway for bereavement counselling.

Pupils in the early stages of emotional and social development because of their special educational needs will be supported to enable them to develop and matureappropriately. This will usually require additional and different resources, beyond that required by pupils who do not need this support.

<u>5</u> Information about the expertise and training of staff in relation to children and young people with special educational needs and how specialist expertise will besecured

All teachers and teaching assistants have had the following awareness training:

Cognition and Learning, Physical Disabilities including Visual Impairment training, epilepsy awareness. Communication and Interaction difficulties including workshopson Asperger's Syndrome and Autism. De-escalation training, specific work on Attachment issues have been delivered to support some of our learners who have Social, Emotional and Mental Health difficulties. All new staff and newly qualified teachers are expected to follow a programme which covers the four aspects of SEND.

In addition, the following staff have received the following enhanced and specialisttraining:

Where a training need is identified beyond this we will find a provider who is able to deliver it. Training providers we can approach are listed through the Local InclusionForum Team with termly meetings. The cost of training is covered by the notional SEN funding.

<u>6</u> Information about how equipment and facilities to support children and youngpeople with special educational needs will be secured

Where external advisers recommend the use of equipment or facilities which the school does not have, we will purchase it using the notional SEN funding, or seek itby loan. For highly specialist communication equipment the school will seek the advice of the KCC Communication and Assistive Technology team.

7 The arrangements for consulting parents of children with special educational needsabout, and involving them in, their education

All parents of pupils at Aylesford School are invited to discuss the progress of their children on a number of occasions a year and receive a written report. In addition, we are happy to arrange meetings outside these times. As part of our normal teaching arrangements, all pupils will access some additional teaching to help them catch-up if the progress monitoring indicates that this is necessary; this will not implythat the pupil has a special educational need. All such provision will be recorded, tracked and evaluated on a Provision Map.

If following this normal provision improvements in progress are not seen, we will contact parents to discuss the use of internal or external assessments which will helpus to address these needs better. From this point onwards the pupil will be identified as having special educational needs because special educational provision is being made and the parent will be invited to all planning and reviews of this provision.

Parents will be actively supported to contribute to assessment, planning and review. These meetings are conducted three times a year.

In addition to this, parents of pupils with an Education, Health and Care Plan will be invited to contribute to and attend an annual review and two further in year reviews, which, wherever possible will also include other agencies involved with the pupil.

Information will be made accessible for parents.

<u>8 The arrangements for consulting young people with special educational needsabout, and involving them in, their education</u>

When a pupil has been identified to have special educational needs because specialeducational provision is being made for him or her, the pupil will be consulted about and involved in the arrangements made for them as part of person-centred planning. Parents are likely to play a more significant role in the childhood years with the young person taking more responsibility and acting with greater independence in later years.

9 The arrangements made by the governing body relating to the treatment of complaints from parents of pupils with special educational needs concerning the provision made at the school

The normal arrangements for the treatment of complaints at Aylesford School are used for complaints about provision made for special educational needs. We encourage parents to discuss their concerns with the class or subject teacher, thechild's mentor, the Assistant Head for the appropriate year, the Assistant SENCO, the SENCO or the Headteacher to resolve the issue before making the complaint formal to the Chair of the governing body.

If the complaint is not resolved after it has been considered by the governing body, then a disagreement resolution service or mediation service can be contacted. If itremains unresolved after this, the complainant can appeal to the First—tier Tribunal (Special Educational Needs and Disability), if the case refers to disability discrimination, or to the Secretary of State for all other cases.

There are some circumstances, usually for children who have decision made about their Education, Health Care Plans where there is a statutory right for parents to appeal against a decision of the Local Authority. Complaints which fall within this category cannot be investigated by the school.

10 How the governing body involves other bodies, including health and social services bodies, local authority support services and voluntary organisations, in meeting the needs of pupils with special educational needs and in supporting thefamilies of such pupils

The governing body have engaged with the following bodies:

- Free membership of LIFT for access to specialist teaching and learningservice
- Link to Disabled Children's Service for support to families for some pupils withhigh needs
- Access to local authority's service level agreement with Speech and Language Therapy Services / Occupational Therapy Services / PhysiotherapyServices for pupil with requirement for direct therapy or advice
- Ability to make ad hoc requests for advice from Communication and AssistiveTechnology Team.
- Membership of professional networks for SENCO e.g. NAS, SENCO forum, NASEN etc.

12 The school's arrangements for supporting pupils with special educational needsin transferring between phases of education or in preparing for adulthood and independent living

At Aylesford School we work closely with the educational settings used by the pupilsbefore they transfer to us in order to seek the information that will make the transfer as seamless as possible. As part of a comprehensive transition process, every childis visited in their primary school by a member of the Leadership Team and the SENCO is met. The school is proactive in being invited to review meetings of students coming to us. Some students will follow a detailed induction programme which may include several additional visits, timetables prior to starting and visual aids/maps of the school.

We also contribute information to a pupils' onward destination by providing information to the next setting. We have established close links with the localcolleges and have set up relevant support meetings.
